## PROCEDURES (NOT NEGOTIABLE)

### 1) (SCO)-(LOI)-(SPA)

2) The Seller and the Buyer can receive a "phone call or corporate mail to sign a (NCNDA) and exchange documents. The Draft of the Contract (SPA) to be signed and sealed by the Buyer. (DLC Issuer) and send the CIS (customer information sheet) of your company.

3) Once the DLC (MT700) is confirmed by the receiving Bank, the Irrevocable Commission Payment Agreement (IMFPA) is immediately signed with the bank accounts of the Commission Groups. and will be signed together with the W-9, W-8ECI, etc. (Foreign Account Tax Compliance Act) (FACTA) and the United States Department of the Treasury (IRS)

4) After the confirmation of the DLC, we will begin to move the material to port and in 5 to 10 business days, and the invitation will be sent to the buyer to physically witness their Products in the Warehouses. And then the product will be loaded in containers by the shipping company. (CMA CGM) and SGS Mexico that certify our Product in the Customs of Mexico.

5) The material is sent to the port to be loaded onto the ship when it arrives at the destination port, the company delivers the bill of lading (B / L) and complete sets of documents are made to be send to the bank and the Buyer after having received the payment through a (SWIFT MT 103.) we can prepare transfers of payments to the links and groups of commissions.

#### **The letter of intent (LOI) must contain the following information:**

- Letterhead signed by the buyer and legal representative firm.
- Key Number and Transaction Code of the SCO. In this case: **GASPRO/CU\_16JD-701** (016-20)
- The issuing Bank or Banks they work with (Top 20)
- Accept the discount with the commissions of the links and groups.
- The purchase procedures must be very specific and clear.
- Name of the Certification Company where they will perform the Chemical Analysis.
- Signature by the CEO of the purchasing company to which the Proforma Invoice is billed.

#### **Important notes:**

Our company declares that the Copper for sale is free of encumbrance, values, interests, charges, claims, optional or limitations for the sale and export, as well as changing the property title in favor of the buyer.

We also declare that this Copper is legally obtained by us and that it is not of Criminal origin.
